IMPORTANT UPDATE ON GRADE XII RESULT ASSESSMENT (2025 -26)

Dear Parents & Students,

Greetings of the day!

We would like to inform you that, as per the latest circular issued by the Central Board of Secondary Education (CBSE) dated **27th March 2026**, important updates have been announced regarding the result assessment of **Class XII Board Examination** for students in the Middle East region (Bahrain, Iran, Kuwait, Oman, Qatar, Saudi Arabia, and the UAE).

1. Status of Examinations

Board examinations for Class XII were scheduled from 17.02.2026 to 10.04.2026. Examinations scheduled up to 28.02.2026 were conducted successfully. Rest all examinations of Class XII scheduled till 10.04.2026 stand cancelled.

2. Assessment Scheme for Result Declaration

To ensure fairness and uniformity, CBSE has introduced the following assessment criteria:

(a) Students who appeared in all registered subjects:-

The result of such students will be declared based on their performance in the examinations as they have appeared in all of their registered subjects.

(b) Students whose 1, 2,3, 4, 5, and 6 examinations are left:-

(i) In this category, assessment will be made based on maximum marks assigned to theory paper and to the Practical/I.A.

(ii) Assessment in Board will be based on the assessment done by the schools.(Term Exams,Half yearly and Preboard exams)

• **Assessment of the subjects with 80 and 70 theory marks**

In subjects where maximum theory marks are 80 or 70, schools will provide the performance of the students to the Board in Term examination, in half yearly examination and in final PreBoard examination. Best of the three marks will be taken into account for calculating result.

• **Assessment of the subjects with 60/50 and 30 theory marks**

In the subjects where maximum theory marks are 60, 50 and 30, school will provide the performance of the students to the Board in final Pre-Board examination(Pre board - 2) only. These marks will be taken into account for calculating the final result.

(In these subjects, if student was "Absent" in the Final Pre-Board Examination then Pre-Board marks which was conducted prior to the Final Pre-Board Examinations will be provided by the school to the Board)

(c) Internal assessment/ Practical marks have already been uploaded by the school. Accordingly, there will be no change in the IA/Practical marks.

(d) Result of the students shall be declared along with rest of the students.

The school will share detailed guidelines, procedures, and timelines once further instructions are received from CBSE. We request all parents to kindly take note of the above information and guide their wards accordingly.
